


Minutes of Pre-Tender Meeting held at HRIDC Gurugram Office, with an option of attending through Video Conferencing, on 11<sup>th</sup> July 2022 at 11:00 hrs regarding Works Contracts Package C -2: Composite Contract Package in connection with laying of New BG Double Railway Line of HORC project for:

(i) Design and Construction of Civil Works (Earthwork, Bridges, Station Buildings, Retaining Walls and other miscellaneous Works) from Km 55.60 to Km 61.50 and its connectivities to IR network from New Patli to Patli & New Patli to Sultanpur including modifications in Sultanpur station yard,

(ii) Design, Supply, Installation, Testing & Commissioning of OHE (1x25 kV) and General Electrical services from Km 49.70 to Km 61.50 and its connectivities to IR network from New Patli to Patli & New Patli to Sultanpur including modifications in Sultanpur station yard and

(iii) Design, Supply, Installation, Testing & Commissioning of Signalling & Telecommunication from Km 49.70 to Km 61.50 and its connectivities to IR network from Manesar to Patli and New Patli to Patli & New Patli to Sultanpur including modifications in Patli and Sultanpur station yards.

- 1) A Pre-Tender Meeting was convened at HRIDC Gurugram Office, Plot No 143,3<sup>rd</sup> Floor, Railtel Tower, Sector -44, Gurugram, Haryana -122003 with an option of attending through Video Conferencing, on 11<sup>th</sup> July 2022 at 1100 hrs regarding Tender No. HORC/HRIDC/C-2/2022. The list of attendees of the meeting is annexed at Annexure -1.
- 2) Mr. Narinder D Chumber, Director (P&P), HRIDC presided over the Meeting. He welcomed the participants in the Pre-Tender Meeting. He gave an overview of HORC Project to the participants.
- 3) Mr. Chahatey Ram, Project Director/GC gave presentation on Contract Package C-2.
- 4) Presentation was distributed into four parts. At end of each part of presentation, participants were given opportunity to raise their queries.  
Tenderer raised queries related to eligibility criteria, scope of work, Permits and clearances, land status, Performance guarantee, retention money, advance payment, extension of time for completion, extension of Bid submission end date and other technical aspects of the Tender.  
Each query was responded to by HRIDC and GC/HORC.  
Prospective Tenderers were advised to submit their queries in writing through email to HRIDC latest by 1200hrs of 12<sup>th</sup> July 2022. It was informed that all the queries raised by the prospective Tenderers will be examined and addressed through Corrigendum wherever required.
- 5) At the end of presentations, prospective Tenderers were explained how to complete Tender Forms for submission of Tenders.
- 6) HRIDC advised all prospective Tenderers to review the Tender Documents carefully and submit Tender forms complete with their Tender.
- 7) Tenderers were advised to make payment of Tender document fee, e-Service Fee & Tender Security well in advance prior to last date of submission of Tender so as to

avoid any problem faced in making payment on the e-Procurement Portal. No extension for date of submission of Tender document shall be allowed on this ground.

- 8) Tenderer were also advised to make a visit to site before preparing and submitting their Tender.
- 9) Pre-Tender meeting was concluded by Director/P&P/HRIDC, who thanked AIB representatives and all the prospective Tenderers for their participation in the Pre-Tender Meeting.
