Haryana Rail Infrastructure Development Corporation Ltd. (HRIDC) is a Joint Venture company of Govt. of Haryana (GoH) and Ministry of Railway (MoR) with an equity participation of 51% and 49% respectively. The company was formed with an objective to develop the Rail Infrastructure for capacity enhancement in the State of Haryana and to carry on Business Development, financing, planning and implementation of Railway projects. Haryana Orbital Rail Corridor (HORC) project from Palwal to Sonipat via Sohna, Manesar & Kharkhoda (bypassing Delhi area) has been approved by Cabinet Committee of Economic Affairs (CCEA) and is being implemented by HRIDC. The project is proposed to be funded through debt, equity and VCF through PD/TOD. The Project has an immense potential to spur economic activities in the region and HORC proposes to leverage land & airspaces at around the Project Alignment through Property/commercial Development opportunities to part finance the Project.

HRIDC proposes to engage a professional having exposure in the field of Town planning/ City Development Plan/ Planning of Industrial Corridors/ Infrastructure Planning for implementation of Land Value Capture (LVC), Transit Oriented Development (TOD) and Value Capture Finance (VCF) initiatives.
